### **Update to all Tier 2 – DC Plan IAMAW Members**

**May 26<sup>th</sup>, 2023**

Brothers, Sisters, Members,

In 2022, myself and Aman Anand (Both Tier 2 – DC plan members) were reviewing our Manulife Pension Plan regular contributions. We had noticed that for the pay period of October 16<sup>th</sup>/2020 and August 13<sup>th</sup>/2021, our Voluntary Pension was deducted from our pay stub but was not actually deposited into our Manulife RPP accounts.

After escalating this to HR (Allison Pinto/Suzanne), they opened up an investigation and found that Veoneer had released the funds to Manulife but Manulife hadn't deposited it into our respective employee accounts.

After considerable work with Veoneer HR and Manulife, these contributions should now finally be in our accounts.

**The dates when the corrections were made for the missed deposits:**

**December 23<sup>rd</sup>/2022** – there should be two “Regular Contribution” deposits on this date. One at your current rate of pay, one will be at your 2021 pay rate.

**April 11<sup>th</sup> /2023** – there should be two “Regular Contribution” deposits on this date. One at your current rate of pay, one will be at your 2020 pay rate.

**DC Plan Members** - Please take this time to log-in to your Manulife VIP room and verify if all deposits are present. ALL DC PLAN MEMBERS SHOULD BE REVIEWING THIS ON A MONTHLY BASIS (Minimum). *Call Manulife @ 1-800-242-1704 if you can't login.*
